The on-line format and questionnaire for collection of students' feedback about curriculum and teaching learning process should be revised as proposed by Mr. Debajyoti Basu, Head IT.
- 3.1 Librarian should implement suitable mechanism to increase the number of e-books available in the on-line library portal and also should consider providing access to e-resources of the library with the assistance of IT Dept.
- 3.2 Optimal utilization of Budgetary allocations for purchase of books and journals should be ensured by the Librarian in consultation with faculty members.
- 4.1 Senior faculty members should be encouraged to register themselves as Ph.D guides with Universities, if eligible as per norms.
- 4.2 PAQIC proposes for introduction of incentive schemes for teachers receiving state, national and international recognition/awards, in order to motivate them to undertake more research activities.
- 5. Among other activities PAQIC shall also perform academic & administrative audit on half yearly basis.
- 6.1 The details of scholarships and freeships provided by the Government to the students should be documented for each year and made available to PAQIC.
- 6.2 The institution as a whole and Pharmacy Dept. in particular is participating in NIRF India Ranking 2019.
- 6.3 Installation of Electronic surveillance system in the campus to ensure safety and security of the stakeholders.
- 6.4 Use of LED lighting systems and solar power should be increased. Green audit should be conducted on half yearly basis.
- 7. The next review meeting is proposed in the month of March-April 2019.
